# Trombone Larry: From the Shelter to the Boardroom



By almost any measure Larry Hickland, aka "Trombone Larry," had the odds in his favor. As a child he was well-loved, well-fed, well-educated, and musically gifted.

In college, Larry was sought out to play with elite musicians, and by age 25 he was thriving. "In the mid-80s everything was good. I was driven. I was playing. I was making money. I had it all," Larry recalled.

From this energetic peak the next twenty years began a slow, incremental, and downward slide toward homelessness. The gigs dried up. Larry got married and divorced twice. After a bad car accident left Larry with a fractured sternum, he found himself struggling with pain, loneliness, and an unclear future. Unable to keep up, Larry lost everything - including his house, his car, and his trombone.

In 2013, at the age of 54, Larry became homeless.

But God and some caring people had their eyes and hearts on Larry. In 2015 a friend mailed Larry a trombone and he started playing again in a church choir. "I had been away from playing, away from God, and away from everything. Finally, I was listening again, and playing again, and things started to come back," said Larry.

Optimistic but still homeless, in 2017, Larry headed home to Dayton, taking a Greyhound bus directly to the St. Vincent de Paul Gateway Shelter for Men on Gettysburg Avenue. Says Larry, "When I was in the shelter, Michael, St. Vincent's Executive Director, would hear me play the trombone. I told him my story and for once in my life I could admit that I was educated, and homeless, and a child of God."

A case manager helped Larry apply and get approved for both disability and an independent living apartment. Having survived the arc of homelessness and living in secure housing for the first time in six years, Larry was eager to give back. Michael knew that Larry could provide a unique and needed perspective for SVdP, so he asked Larry to serve on the SVdP Community Board and he agreed.

Says Larry, "There was a time in my life when I thought I was below everything and not worth anything. Now I get to help people embrace God and help SVdP understand what it really is like to be homeless."

And that is music to our ears.

The St. Vincent de Paul Society Dayton District Council is pleased to announce our new shelter chapel, welcoming all who wish to worship with our Catholic community or visit for personal prayer and reflection. The St. Vincent de Paul Chapel was dedicated on November 17 by Archbishop Dennis Schnurr, who celebrated the chapel's first Mass. We now offer daily Mass at 5:30 p.m., Monday through Friday.

The chapel is simple, reflecting our mission of service, and a beautiful space of peace and reflection. The pews and altar



from a former worship space were beautifully restored for our chapel. The door cornices, additional pews, and niches for the tabernacle and statuary were crafted by staff members, and the piano was donated by a local church. The statuary, Stations of the Cross, and sanctuary appointments create a balance of reverence and simplicity. The chapel is truly a community project, and we thank all who generously shared of their gifts and labor. It is a prayerful space for anyone desiring to draw closer to God.

The St. Vincent de Paul Chapel is located within the Gateway Shelter for Women and Families at 124 W. Apple Street. All are welcome to join us for community worship or personal prayer, which is often the first experience of church worship for our homeless guests.

After entering the main door of the shelter, you will pass through security into the front desk area. Turn right and enter through the double glass doors. The entrance to the St. Vincent de Paul Chapel is halfway down the hallway.

In addition to daily Mass at 5:30 p.m., Monday through Friday, the chapel provides personal adoration of the Blessed Sacrament 2:00 – 5:00 p.m. Please join us any time!

# **Charitable Giving through Your IRA**

Shortly after they turned 70 years old, Barbara and Carl Denison learned from their financial advisor that making a Qualified Charitable Contribution from their IRAs was a great way to reduce their taxable income. "We want to support our own local area as much as we can. Especially since the tax rules have recently changed, it makes the QCD even more attractive to the taxpayer," said Carl. And as long-time donors to St. Vincent de Paul, they both knew those needing food, clothing, and shelter would benefit from their charitable contribution. "When we took a tour of the shelter, we were impressed with the services SVdP provides in addition to temporary housing," Barbara shared.

### Here are some facts and SECURE Act updates on Charitable Giving with an IRA:

- If an individual has an IRA, at a certain age they must begin drawing a Required Minimum Distribution. Unfortunately, this distribution is taxed as ordinary income and increases tax liability.
- However, turning that Required Minimum
  Distribution into a Qualified Charitable
  Distribution—by giving it directly to a qualified
  non-profit such as St. Vincent de Paul—means
  one does not have to pay taxes on that charitable
  amount. So even if you don't itemize, you
  could save taxes.
- The recent SECURE Act increased the Required Minimum Distribution age to 72 years, up from 70 ½ years. However, this development applies only to folks who reach 70 ½ after 2019. So if you turned 70 ½ in 2019 or earlier, you are unaffected by the new law.
- Despite the SECURE Act delay in the starting age for Required Minimum Distributions,
   Qualified Charitable Distributions may still be gifted from IRAs as early as age 70 ½ .

The Denisons noted, "You don't have to be wealthy to give through an IRA. The amounts do not have to be large." This is so true: IRA gifts to SVdP have ranged from hundreds to tens of thousands of dollars, and all will make a difference to someone with great need!

# The Best Giving Tuesday Ever: Feeding the Hungry

Your generosity raised over \$16,000 and provided for the replacement of six food freezers throughout our food ministry. Two new upright freezers used to prepare our shelter meals and four new chest freezers for our community food pantry are already in use. These freezers were much needed to replace failing equipment for our food ministry that feeds 25,000 individuals each year.

As your donations exceeded our Giving Tuesday goal, you helped satisfy another food ministry need! Most of the funds for a new food transport van came from a community grant. Giving Tuesday completed that funding. Over 1,200 meals are prepared every day at our Apple Street Shelter, and we need a van to deliver meals that volunteers serve to our guests at the Gettysburg Men's Shelter. The food van also provides flexibility in picking up food at the Dayton Food Bank, when timeliness is important to pick up unexpected fresh produce donations. Thank you for helping us feed our guests in emergency shelter!
